1) Call to Order – Flag Salute at 7:03 pm.

2) CAB Recorder for this meeting is Roy Barba.

3) Minutes of the previous meeting (August 18th, Kurt Almond) Approval postponed until October, as they were not available to vote on at this meeting. All CAB <u>approved</u> minutes are posted at <u>crestonadvisorybody.com</u>

4) Limited Public and/or CAB Member Comments for Items NOT on the agenda Including Community events and other items of interest. None at this time.

5) Public Safety -

Sheriff's Department - Deputy Matthew Barksdale - see attached description list. CHP - Lieutenant Chandler Stewart - Templeton Station – not present Cal Fire - Fire Captain – Jesse Ryan or Chad Mitchell – not present

6) Fifth District Supervisor Report–Supervisor Debbie Arnold – Zoom

Supervisor Arnold stated that at the previous BOS Meeting they voted 4-1 to support PROP. 35 and PROP. 36. Bruce Gibson was against.

35 would increase reimbursements for doctors which would encourage more healthcare providers for area.

36 would attempt to rectify some of the issues with PROP 47 i.e., misdemeanor for theft under \$950. (Supervisor Gibson voted not to support this item.)

7) Planning Department Update & Project Referrals - CAB Liaison-Lane Sutherland Lane stated that he will no longer be the county liaison for CAB, he will be handling South County.

Dominic Dal Porto will be taking over as CAB liaison beginning next month.

a. Cannabis projects update – Jim Wortner.

Creston began with 12 proposed cannabis applications now there are only 2 remaining. Webster Road which has fees due and Creston Road which has paid their fees.

b. Air Stream Trailers/Jhelum Vineyard permit/La Panza parcel grading – Thomas Edel No action taken.

c. Planning Commission Hearing Sept. 26th on two proposed Creston Verizon Towers

Coordination of community efforts. No action taken.

8) Unfinished Business – Code Enforcement updates.

Stadium Lights at 6495 O'Donovan Road, 10 acre parcel.

Code Enforcement found no code violations at the time of their visit. Property owner Lee Alegre and resident Tonya Marshall were present along with two other proponents of the lights. The other two stated they use the facility at night for rodeo type activity and were supporting the existence of the lights. These stadium lights are very bright and are a nuisance to a number of Creston residents, at least one neighbor immediately next door, and even some from a distance away. It was agreed that the lights would be redirected to a more downward position in an attempt to alleviate the brightness and nuisance they are causing at present. Noise is also a problem. Code says noise can not go more than 100ft... past the property line. Don Clark will do a site visit with the neighbor immediately affected and the property owner and hopefully code enforcement representative.

9) New Business -

It was agreed that CAB will donate \$85 towards a brick honoring Supervisor Arnold's 12 year's of service and her unwavering support of the Creston Community. Unanimous vote.

10) Report from the Paso Basin Cooperative Committee

– Murray Powell reported there will be a Water Council Meeting on September 25, 2024.
